Pride in Putāruru is a not-for-profit organization that has a business association role, facilitating functions and events on behalf of the Putāruru business community and residents. Events include the Putāruru Water and Food Festival, Farmers Night, Business Awards, Pink Walk, Matariki, Shop and win, Christmas Parade among other initiatives. Pride in Putāruru also produces the Putāruru Prattler newspaper distributed free to the Putāruru and Tirau Wards.

Pride in Putāruru also manages the Information center that is partially funded by Council through a targeted rate on both the business sector and Putāruru ratepayers. The organisation secures additional funding from grants and donations.



- 4. The terms and conditions of this agreement shall not be disclosed to any third parties without the prior written consent of both parties.
- 5. The rights of either party under this agreement shall not be transferable or assignable either in whole or in part without the written consent of the Promoter.
- 6. The Promoter is not responsible for any late, lost, or misdirected entries, including but not limited to entries not received due to technical problems.
- 7. The Promoter is not responsible for the transmission or receipt of any incorrect information associated with entries.
- 8. The Promoter is not responsible for damages or any lost promotional materials.
- 9. The Sponsor must deliver all promotional and advertising materials including but not limited to flyers, business cards and flags to the Pride in Putāruru office no later than 12pm Friday 21st June 2024.
- 10. The Promoter reserves the right to select the sponsors to participate.
- 11. The Promoter reserves the right to have two 'Major Sponsors' highlighted.
- 12. The Sponsor and or representative will always act in a professional manner.
- 13. The Promoter reserves the right to terminate this agreement for:
- (1) False or misleading details that has been given by a sponsor, representative or participant and any other reason the Promoter deems is likely to undermine the Sponsorship and or the Event.
- (2) The Sponsor or their representative behaving in a fraudulent or dishonest manner.
- 14. The Promoter reserves the right to recover from the Sponsor any loss or damage caused by the Sponsor and/or its representative and incurred or suffered by the Promoter, the Event Venue, the Online Event Platform or any other participants.
- 15. The Promoter reserves the right to refuse entry by any Participant to the Event or to remove any Participant including a Sponsor from the Event or to 'block' them from an Online Event Platform without any liability for any reason and at their sole discretion.
- 16. If the Event is not capable of running as planned for any reason beyond the reasonable control of the Promoter, including but not limited to, tampering, unauthorised intervention, acts or omissions of third parties, technical failures, acts of God, security risks or anything which corrupts or affects the safety of the Event then The Promoter reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the event. Any cancellation, termination, modification, or suspension will be publicly notified by the Promoter on their website.
- 17. If the Event is terminated or cancelled, payments received from sponsors will be reimbursed within 30 days following the date of cancellation. However, if the Event is postponed, payments will be retained in anticipation of the postponed date unless agreed otherwise.
- 18. Payment in full of any applicable costs associated with the Event is due upon registration or not later than 1st of June 2024. If the Sponsor fails to make sufficient payment of any applicable costs, the Promoter may at their discretion refuse participation and or entry to the Event.
